### Financial highlights:

- Revenues declined by 19.6% YOY to EUR 5.131 million;
- EBITDA increased by 172% YOY to EUR 1.299 million (EUR 2.063 million without 26% levy);
- EBIT jumped by 87.3% YOY to EUR -0.415 million (+EUR 349 million without 26% levy)
- Before taxation almost break-even with a loss of EUR 1.044 million compared to loss of EUR 12.029 million in Q3 2012 (without 26% levy a profit before tax of -EUR 280 thousand in Q3 2013);
- Total comprehensive income of EUR 5.05 million (-EUR 4.286 million without 26% levy) compared to EUR - 12.506 million in Q3 2012;
- Equity increased from EUR 10.455 million in Q3 2012 to EUR 29.797 million in Q3 2013;
- Equity ratio reached a solid 35%<sup>1</sup>;

#### 2. Management discussion and analysis

#### 2.1. A note from the Management Board

Following the listing of the Company's shares on the NewConnect market of the Warsaw Stock exchange in the second quarter, in Q3 2013 our Company embarked on the implementation of its strategy. As previously announced Photon Energy has initiated the process of preparing for an IPO and listing on the main market of the Warsaw Stock Exchange in 2014. Simultaneously, the management is evaluating multiple options for raising equity via private placement and corporate debt.

In September 2013 Photon Energy was accepted into the WIG-CEE index of the Warsaw Stock Exchange with a 0.1% weighting. WIG-CEE is a total return index and thus when it is calculated it accounts for both prices of underlying shares and dividend and subscription rights income. The index portfolio may include companies from Central and Eastern Europe with shares listed on the regulated market or in the alternative trading system NewConnect operated by the Warsaw Stock Exchange.

At the end of June 2013 the Company executed a capital increase and issued 27 million ordinary shares with a nominal price of EUR 0.01, which were introduced to trading on NewConnect shortly after the reporting period in October 2013 and registered in the Polish National Depository for Securities (KDPW) at the beginning of November 2013.

Furthermore, on 12 September 2013 our fully-owned subsidiary Photon Energy Investments N.V. paid the second quarterly coupon for its 5-year corporate bond. Since its introduction to trading in March the price of the bond remained stable around its face value with the September closing price at 99.75.

In the Czech Republic, the Company's core market as far as its portfolio is concerned, negative developments regarding the Solar Levy and retroactive legislative measures continued. Photon Energy had to write down the value of 14.2 MWp of PV plants in the Czech Republic in the portfolio of its fully-owned subsidiary Photon Energy Investments by 4.517 million. On 17 September the Czech president Miloš Zeman signed a Bill extending the controversial retroactive Levy for the remainder of the applicable Feed-in-Tariff period for PV plants connected in 2010 (about 1,400 MWp affected) at the level of 10% of revenues. The Bill had previously been passed by the Czech Senate on 13 September.

Photon Energy N.V. has been successful in riding out the storm in the industry and is on the right track towards becoming a leading force in the upcoming solar age where competitive solar energy will rapidly become the key energy source globally. Until now PV plants under Feed-in-Tariffs or similar government support systems before were mere financial investments. In the solar age the motivation to build PV plants will be to serve the needs of real-world energy users ranging from industrial and commercial clients to households. This fundamental paradigm shift requires a comprehensively holistic approach, starting with each customer's energy demand profile. For that reason Photon Energy has initiated a strategy review with particular focus on activities providing recurring uncorrelated revenue streams such as Operations & Maintenance, Energy Management, Standardised Financing Solutions and Independent Power Production from the Company's proprietary portfolio.

After an extended period of poor weather conditions in Europe from the beginning of the year, Q3 2013 saw a substantial improvement on the previous quarters with record temperatures and sun irradiation. This led to greatly improved production results of Photon Energy's proprietary portfolio with the accumulated average performance amounting to nearly 10.7 GWh, exceeding energy forecasts by an average of nearly 6%. In July the major part of the Company's proprietary even recorded the best generation results in their history (for more information, please refer to the monthly report for July 2013). Following record breaking results in July the power plants in the Company's proprietary continued outperforming generation estimates in August and September.



Financially, Q3 2013 can be considered a success despite the 19.6% decline in consolidated revenues to EUR 5.131 million, most of which were realised through the sale of 10.7 GWh of PV-generated electricity. The decline was solely due to exceptionally bad weather conditions in Central Europe since the beginning of the year, resulting in energy production coming in at 9% below plan. Without the 26% levy on the revenues of our Czech PV plants we would have reached the pre-tax level with a loss of EUR 280 thousand, while due to the levy we recorded a loss of EUR 1,044 thousand. Total comprehensive income resulted in a negative amount of EUR 5,050 thousand and would have been EUR -4,286 thousand without the levy. EBITDA improved by 172% YOY to EUR 1.299 million (EUR 2.063 million without the levy) and EBIT jumped by 87.3% to EUR -415 thousand (EUR 349 thousand without the levy).

The most important non-operational events in Q3 2013 that should be highlighted were: a) result of the reverse auction for a 20-year FIT in the Australian Capital Territory, b) Photon Energy Operations took over the service of 9 MWP of Satcon Inverters in Italy and France and c) Photon Energy Australia was chosen to install a 290 kWp PV in Sydney.

#### a) Result of the reverse auction for a 20-year FIT in the Australian Capital Territory

At the end of August the results of the reverse auction for a 20-year FIT in the Australian Capital Territory (ACT) were announced.

While Photon Energy successfully passed the pre-selection and qualified for the final auction together with a very limited number of companies, the Company was not part of the final selection chosen for the FIT.

The auction was Photon Energy's first attempt of securing a FIT in Australia and given the Company's short presence "Down Under", having qualified for the final round is an astonishing result.

While Photon Energy wants to pursue mainly grid-parity projects aimed directly at customers, the possibility of applying for similar FITs is still on the table.

### b) Photon Energy Operations took over the service of 9 MWp of Satcon Inverters

Photon Energy Operations CZ s.r.o. (PEO) signed contracts for a wide range of maintenance services for 9 MWp of Satcon central inverters in Italy and France.

With this step the company is fortifying its position as a leading force in the service of Satcon-built inverters, which it established by taking on key personnel from the failed manufacturer. PEO will provide regular preventive checks, service interventions, remote support and technical training for local staff allowing for minor issues to be fixed locally.

#### Photon Energy Australia was chosen to install a 290 KWp PV system for a major Sydney office building

Photon Energy Engineering Australia Pty. Ltd., a fully-owned subsidiary in Australia, has been selected to build and operate a 290 kWp roof mounted PV system on a large office building in Sydney in Australia.

As one of the largest ever installed in the inner city environment in Australia the solar PV system will be used to cover daytime loads with the possibility to export surpluses to the grid, thus generating additional revenue.

Moreover, the PV system will assist in achieving a 5-Star Greenstar and 5 Star-NABERS rating, two rating systems evaluating the environmental design and construction of buildings. The system is designed to cover a certain amount of electricity to the building per annum in order to meet the NABERS rating and utilise



the available roof surface to maximise the output per square meter at the lowest cost per kWh.

#### 2.2. Strategy and its execution

The objective of the Photon Energy Group is the geographic expansion and diversification of its activities and portfolio, in order to use its global presence to minimise regional risk associated with fluctuations. The Group continuously monitors international developments in the area of solar technology and on financial markets. It pays close attention to the development of regulations regarding the solar energy sector in individual countries. The expansion to countries such as Australia, Canada, and Turkey is crucial in the light of current developments, as the Group believes these countries could provide a suitable environment for photovoltaic power plants on the basis of climatic conditions (especially solar radiation), existing infrastructure, possible project financing and legal framework conditions. Other markets are being analyzed on an ongoing basis.

In order to reduce the dependence on government subsidies in the future, the Group's strategy mainly focuses on the expansion to markets which have already reached Grid Parity, i.e. the cost of PV-generated electricity is competitive with grid-supplied electricity.

Apart from geographical diversification the Group intends to specialize in energy generation solutions providing hybrid-system and diesel-replacement solutions for energy-intensive industries. In this area Photon Energy intends to focus on industries such as mining, retail, agriculture, telecommunications and others. In the case of remote off-grid locations, where usually irradiation levels are constantly high throughout the year, such energy solutions allow customers to reduce fuel consumption by up to 100%. In on-grid locations, energy efficiency solutions can materially lower monthly electricity bills. There is no one single solution since every customer has different needs, where the finance and the engineering world need to blend perfectly to deliver the solution our customers need. Photon Energy wants to position itself at the cutting edge of the industry, creating PV-based power solutions with the integration of energy storage and/or diesel generators. The Group has developed different accurate models for off-grid and on-grid systems with sufficient flexibility to adapt to a wide range of situations.

The Group also intends to become a leading global provider of operations and maintenance (O&M) services for photovoltaic plants, particularly in well-established markets with significant installed photovoltaic capacities such as Germany, Italy, the Czech Republic and Slovakia as well as Spain. Further expansion of O&M services is foreseen in countries where the Group currently develops and installs new PV power plants.

In order to facilitate market penetration, the Group will selectively cooperate with local partners, if necessary or value-adding.

### 2.3. Investment action plan and its implementation

The Company did not publish any investment action plan. As a result no plan was implemented.



# 2.4. Proprietary portfolio, generation results and O&M service

Photon Energy N.V. has undergone a restructuring process which included concentrating the entire photovoltaic power portfolios in the Czech Republic, Slovakia, Italy and Australia with one of its six subsidiaries, Photon Energy Investments N.V.

The table below presents the portfolio of power plants owned directly or indirectly by Photon Energy N.V. at the end of the reporting period i.e. as of 30 September 2013, consisted of 29 power plants in the Czech Republic, Slovakia, Italy, Australia and Germany with a total installed capacity of 27.1 MWp. More information on the Group structure and the restructuring processes can be found in chapter 8. Group structure.

In the reporting period there were no major events, which resulted in the material changes of the proprietary portfolio of Photon Energy N.V.

Thanks to exceptionally favourable weather conditions in Q3 2013 the majority of the power plants in the portfolio were performing above expectations. The accumulated average performance of the proprietary power plants connected and feeding electricity to the grid in Q3 2013 amounted to nearly 10.7 GWh and was above the energy forecasts by an average of nearly 6%. On a year-to-date basis it recorded an underperformance of 1% against generation estimates (down by 9% YOY), which is due to exceptionally bad weather conditions in the first two quarters of 2013. Detailed generation results for each power plant are being published on a monthly basis in our monthly reports.

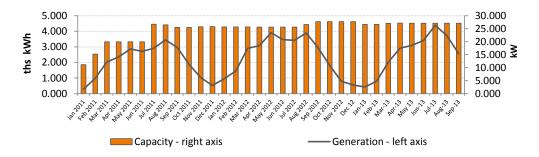

Currently the total O&M portfolio can be broken down geographically into 30.8 MWp operated in the Czech Republic, 10.8 MWp in Slovakia, 5.7 MWp in Germany, 15.3 MWp in Italy, 3.0 MWp in Belgium, 3 MWp in France and 0.3 MWp in Australia. The O&M portfolio includes 27.2 MWp of PV capacities from the proprietary portfolio and 41.8 MWp for external clients. The traditional PV markets with large installed bases in the European Union remain very attractive for our operations and maintenance business unit Photon Energy Operations given that the installed base across the European Union currently exceeds 70 GWp.



### 2.5. Financial statement analysis

#### **Profit and Loss statement**

Consolidated revenues declined in Q3 2013 compared to the same period of the previous year from EUR 6.375 million to EUR 5.131 million. The decrease was caused primarily by lower production of electricity resulting from bad weather conditions.

Despite lower revenues in the current quarter, the Group managed to arrive at a positive EBITDA of EUR 1.299 million (EUR 2.063 million without tax levy). This was mainly achieved thanks to a significant decrease of other administration expenses (by EUR 3.997 million compared to the same period of the previous year).

EBIT jumped from negative EUR -3.236 million to negative EUR -0.415 million (positive result of EUR 0.349 million without tax levy).

Net profit amounted to a loss of EUR 1.06 million (loss of EUR 0.296 million without tax levy) in Q3 2013 compared to a loss of EUR 11.898 million in Q3 2012.

Other comprehensive income was negatively influenced by the revaluation of power plants in the Czech Republic due to new tax levy of 10% for the entire useful economic life of the powerplants approved by the Czech government and coming into effect in 2014. The negative impact of this revaluation was EUR 4.517 million, slightly compensated by the positive result of hedging and currency reserves of EUR 0.527 million.

Total comprehensive income increased from negative result of EUR -12.506 million in Q3 2012 to negative result of EUR -5.05 million in Q3 2013.

Chart 2. Revenues, gross profit and gross margin

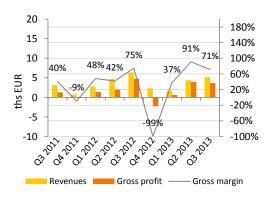
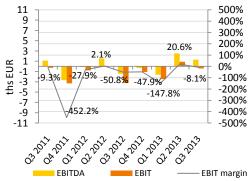


Chart 3. EBITDA, EBIT and EBIT margin development



#### **Balance Sheet**

Total assets amounted to EUR 98.688 million at the end of Q3 2013 and decreased by EUR 9.193 million compared to Q3 2012. The main reason for the decrease of the total assets was the fall in the value of the fixed assets. Most of its value is represented by the fair value of the power plants that is reviewed on a quarterly basis. Because of the approval of a 10% tax levy for the entire useful economic life of the power plants by the Czech government, coming into effect in 2014, the value of the power plants located in the Czech Republic has been recalculated. The total impact of this revaluation including the deferred tax effect was EUR 5.576 million (EUR 4.517 million without deferred tax). The rest of the decrease in the value is caused by the annual depreciation.

On the other hand, current assets increased from EUR 11.678 million as of 30 September 2012 to EUR 13.815 million as of 30 September 2013 mainly due to higher cash and cash equivalents available.



As a result of a capital increase of EUR 24 million, equity has increased in Q2 2013 to EUR 34.847 million. However, this value has been negatively impacted by the mentioned revaluation of power plants with total impact of EUR 4.517 million. The remaining difference is the result of current period profit and changes in hedging and currency reserves.

Total liabilities amounted to EUR 53.163 million as of the end of the current quarter compared to EUR 75.609 million as of the end of Q3 2012. The main drivers of this decrease were a partial repayment of other loans (EUR 6 million of the end of Q3 2013) and a decrease of other long-term liabilities resulting from a restructuring by almost EUR 24 million. Group also managed to decrease its trade and other payables compared to the previous year (from EUR 9.538 million to EUR 6.403 million).

Chart 4. Net current assets

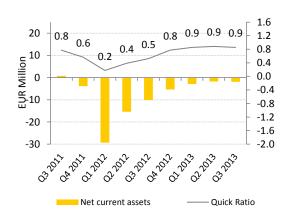
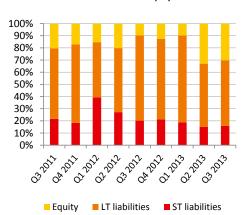


Chart 5. Break down of liabilities and equity



# **Cash Flow**

The Group posted a positive operating cash flow in Q3 2013, which amounted to EUR 1.161 million. Financial cash flow resulted in negative EUR 0.565 million primarily due to repayment of borrowings and the payment of the subsidiary Photon Energy Investments' bond coupon, slightly compensated by proceeds from issuing the bond. Overall, net change in cash resulted in an increase by EUR 0.596 million to cash at the end of period of EUR 5.529 million.

Chart 6. Operating, investment and financing cash flow

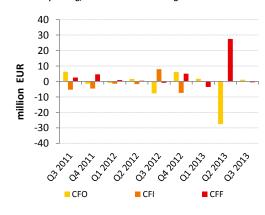
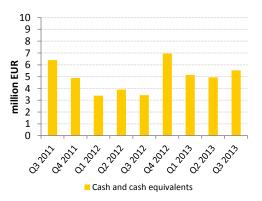


Chart 7. Cash position at the end of the period

# Changes in equity

As a result of a capital increase of EUR 24 million, equity has increased in Q2 2013 up to EUR 34.847 million. However, this value has been negatively impacted by the mentioned revaluation of power plants with a total impact of EUR 4.517 million. The remaining difference is the result of actual result and changes in hedging and currency reserves.

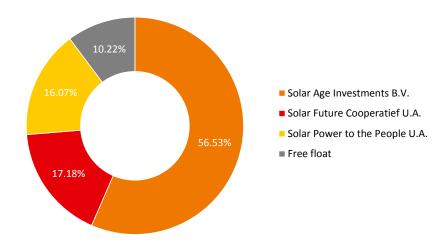

# **Supervisory Board**

Under Dutch law, a public company is required to establish a supervisory board if:

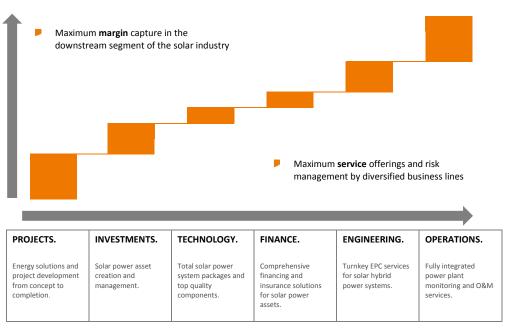

### 15. Summary of significant accounting policies

### **Basis of preparation**

Our accounting policies are based on International Financial Reporting Standards (IFRS) as adopted by EU and were authorised for issue by the Board of Directors.

The following main standards are applied by Group:

### Use of estimates and judgments

In preparing the financial information, the Company's management uses estimates and makes assumptions that affect the application of accounting policies and the amounts of assets, liabilities, income and expenses recognised in the financial information. These estimates and assumptions are based on past experience and various other factors deemed appropriate as at the date of preparation of the financial information and are used where the carrying amounts of assets and liabilities are not readily available from other sources or where uncertainty exists in applying the individual accounting policies. Actual results may differ from the estimates.

Estimates and assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised either in the period in which the estimate is revised, providing that the revision relates only to the current accounting period, or in the revision period and future periods, providing the revision affects both the current and future periods.

#### **Provisions**

A provision is recognised if, as a result of a past event, the Group has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provision are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability.

#### Presentation of Financial information

Financial information is presented based on historical costs with exemptions when IFRS requires different evaluation methods as described below in accounting policies. The statement of comprehensive income is presented with revenues and expenses classified by purpose (function). The cash flow statement is prepared using an indirect method.

Functional currency is the EURO (EUR) and for the purpose of the reporting, as required by the regulations of the Alternative System of Trading organised by the Warsaw Stock Exchange - NewConnect, the balances are retranslated into PLN currency.



#### Consolidation

# (a) Subsidiaries

Subsidiaries are all entities (including special purpose entities) over which the group has the power to govern the financial and operating policies generally accompanying a shareholding of more than one half of the voting rights. The financial statements of subsidiaries are included in the consolidated financial statements from the date that control commences until the date that control ceases.

The purchase method of accounting is used to account for the acquisition of subsidiaries by the group. The cost of an acquisition is measured as the fair value of the assets given, equity instruments issued and liabilities incurred or assumed at the date of exchange, plus costs directly attributable to the acquisition.

The excess of the cost of acquisition over the fair value of the group's share of the identifiable net assets acquired is recorded as goodwill. If the cost of acquisition is less than the fair value of the net assets of the subsidiary acquired, the difference is recognised directly in the income statement.

Income and expenses of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the effective date of acquisition and up to the effective date of disposal, as appropriate.

Inter-company transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated.

Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the group.

### (b) Associates

Associates are all entities over which the group has significant influence but not control, generally accompanying a shareholding of more than 20% and less than 50% of the voting rights. Investments in associates are accounted for using the equity method of accounting and are initially recognised at cost. The cost of the investment includes transaction costs.

The group's share of its associates' post-acquisition profits or losses is recognised in the income statement, and its share of post-acquisition movements in reserves is recognised in reserves. The cumulative post-acquisition movements are adjusted against the carrying amount of the investment.

When the Group's share of losses exceeds its interest in an equity-accounted investee, the carrying amount of that interest, including any long-term investments, is reduced to zero, and the recognition of further losses is discontinued except to the extent that the Group has an obligation or has made payments on behalf of the investee.

Unrealised gains on transactions between the group and its associates are eliminated to the extent of the group's interest in the associates. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred.

Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the group.

# Segment reporting

An operating segment is a component of the Group that engages in business activities from which it may earn revenues and incur expenses, including revenues and expenses that relate to transactions with any of the Group's other components. All operating segments' operating results are reviewed regularly by the Group's management and directors to make decisions about resources to be allocated to the segment and to assess its performance, and for which discrete financial information is available.



The Company's Management has assessed the Group's business from the segment reporting perspective and decided that they financial results of Photon Energy Group to be reported per segments from the objective perspective from 1. 1. 2010.

As of 1<sup>st</sup> January 2012, Management Board has decided to decrease number of segments reported (due to the restructuring performed in 2012) to Engineering and Other.

The Management identified the following segments:

- Wholesale and import of FVE components,
- Engineering and construction services (turn-key photovoltaic systems' installations for external clients and Photon Energy),
- Production of electricity (includes SPE that finished building of photovoltaic power plants and those are connected to the distribution network and produce the electricity)
- FVE Investment This segment represents OCI of the Group flowing from the revaluation of the FVE
  producing the electricity and it is related to project companies that generate the revenues as shown in
  segment Production of electricity.
- Operations, maintenance and PVPP supervision
- Other, not related to any of the above mentioned segments.

Other operations include the financing and insurance solutions for PV investors, intermediating investments in rooftop photovoltaic projects and other less significant activities. None of these operations meets any of the quantitative thresholds for determining reportable segments in 2013 or 2012.

Segment results that are reported include items directly attributable to a segment as well as those that can be allocated on a reasonable basis.

Segment capital expenditure is the total cost incurred during the year to acquire property, plant and equipment, and intangible assets other than goodwill.

### Foreign currency translation

#### (a) Functional and presentation currency

Items included in the consolidated financial information of each of the group's entity are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). The consolidated financial information is presented in EUR, which is the company's functional and the group's presentation currency.

The consolidated financial information is presented in EUR, however, for presentation purposes; the financial information is translated into PLN as the presentation currencies. Effect from this translation is presented in Equity - in the Fund for currency conversions.

Exchange rates as shown in table below were applied. All exchange rates were provided by the European Central Bank. Statement of financial position applicable exchange rate represents the exchange rate as of the last day of the reporting date as according to IAS 21. Statement of comprehensive income exchange rate represents the average of daily exchange rates effective within the relevant period.

#### (b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the income statement.

#### (c) Group companies

In case of entities, whose functional currency is CZK, the financial statements are retranslated at the consolidation into EUR using year-end rate for balance sheet and average rate for profit/loss items.

### Property, plant and equipment

Property, plant and equipment are carried at their fair values, with the exemption of fixed assets under construction which are carried at costs.

#### **Inventories**

Inventories are measured at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and selling expenses. The cost of inventories is based on the weighted average principle, and includes expenditure incurred in acquiring the inventories, production or conversion costs and other costs incurred in bringing them to their existing location and condition.

#### Revenue recognition

Revenue comprises the fair value of the consideration received or receivable for the sale of goods and services in the ordinary course of the group's activities. Revenue is shown net of value-added tax, returns, rebates and discounts and after eliminating sales within the group.

The group recognizes revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and when specific criteria have been met for each of the group's activities as described below. The amount of revenue is not considered to be reliably measurable until all contingencies relating to the sale have been resolved. The group bases its estimates on historical results, taking into consideration the type of customer, the type of transaction and the specifics of each arrangement: the revenues related to development projects (PV power stations) are measured by the percentage of completion method (refer below to Construction contracts).

# Trade receivables

Trade receivables are recognised at nominal value, less provision for impairment.

A provision for impairment of trade receivables is established when there is objective evidence that the group will not be able to collect all amounts due according to the original terms of the receivables. Significant financial difficulties of the debtor, probability that the debtor will enter bankruptcy, and default or delinquency in payments are considered indicators that the trade receivable is impaired. The amount of the provision is the difference between the asset's carrying amount and the present value of estimated future cash flows. When a trade receivable is uncollectible, it is written off.

### Cash and cash equivalents

Cash and cash equivalents include cash on hand and current accounts with banks and term bank deposits.



### Share capital

Ordinary shares are classified in equity as Issued share capital. Consideration received above the nominal value of the ordinary shares is classified in equity as Share premium.

#### **Trade payables**

Trade payables are recognised at nominal value.

### **Loans and Borrowings**

Loan and Borrowings are classified as short-term liabilities (due within 12 months after the reporting date) or long-term liabilities (due more than 12 months after the reporting date).

Financial costs related to construction period of internal non-current assets are capitalised (refer to Property, plant and equipment).

### Current and deferred income tax

The tax expense for the period comprises current and deferred tax.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the reporting date in the countries where the company's subsidiaries and associates operate and generate taxable income.

Deferred income tax is recognised on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial information. Deferred income tax asset is recognised by the Group in case the Management anticipates the future profits will offset the current income tax asset.
